APPLICATION INVITED FOR FINANCIAL SUPPORT IN INDIGENT CIRCUMSTANCES FOR THE YEAR 2020-21.

The office of the Development Commissioner (Handicrafts) invites applications from the eligible Master Craftsperson who have completed the age of 60 years on or before 31st March, 2021 for the year 2020-21 for Financial Assistance in Indigent Circumstances @ Rs.5,000/- (Rs. Five thousand Only) per month as per the guidelines as detailed below: -

- 1. Master craftsperson who are the recipient of Shilp Guru Award, National Award, Merit Certificate or State Award in Handicrafts will be eligible for being considered for financial assistance.
- 2. The annual income of the artisans should not exceed to Rs. 1,00,000/-. An income certificate for the financial year 2020-21 issued by the Office of District Magistrate/ Revenue Department /Tahsildar/ Collector/ Circle officer of the concerned state is necessary as a proof of income.
- 3. The applicant should not be a recipient of similar financial assistance from any other source.
- 4. The artisans should not be less than 60 years of age on 31<sup>st</sup> March, 2021. Age may be relaxed in case of artisans with disabilities.
- 5. Details of the applicant, filled in application, should be verified as per the guidelines of the scheme and his/her photo on the application form and award certificate should be attested by the concerned officer of Handicrafts Service Centre /Regional Office, before recommending the application to this office.
- 6. Required affidavit regarding age, Income and non-receipt of any financial assistance from other sources should be countersigned by District Commissioner/Dy. Commissioner/District Collector/1st class Magistrate.

The interested eligible Master craftsperson may submit their application, in the prescribed Performa available on the website of this office to the concerned Handicrafts Service Centre(s)/Regional Office(s) of this department latest by **31.12.2021** to enable them to forward the same with their comments/recommendation to this office latest by **15.01.2022**. The.
