The undersigned is directed to invite the proposals from eligible organisations **as per new scheme guidelines** for the remaining approved venues as per annual domestic marketing plan for the year 2021-22 for organising domestic marketing events.

The proposal for organizing marketing event from the NGO's must be submitted through NGO portal only. In case of Govt. organisation, the proposal may also forward through email to marketinghandicrafts@gmail.com or mkt-dchc-textiles@gov.in. While recommending the proposal for any marketing activity, the following check points may be ensured by the concerned Assistant Directors.

- 1. The proposal must be recommended only as per the remaining venues attached herewith.
- 2. To promote eoffice initiative, it must be ensured that no hard copies of the proposal are submitted at HQ office.
- 3. TA/DA and freight charges proposed should be as per the entitlement.
- 4. No. of participants proposed should be clearly mentioned.
- 5. Govt Corporations/agencies may be preferred for the proposals of Integrated Marketing Event/National Handicrafts Fair, Thematic Exhibition and Gandhi Shilp Bazaars.
- 6. In case of recommended proposals for NGOs, preference must be given to the organisation with experience in handicraft sector.
- 7. It must be ensured that the implementing agency submit their proposal by **22.11.2021**
- 8. While recommending the proposal, the concerned Assistant Director must inform the approximate footfall and expected sales to be generated during the event.
- 9. All the field offices is requested to scrutinize the proposals and may either recommend or reject the proposals by 23.11.2021.
- 10. No proposal should remain pending at the end of Assistant Director (H), Handicrafts Service Centres by 23.11.2021.
