ORDER**Subject : Designation of Central Public Information Officers (CPIOs) for the Societies/ Apex Bodies/Councils, First Appellate Authority (FAA) under the RTI Act,2005**

It has been observed over a period of time that whenever RTI Section, O/o the DC (Handicrafts) refer any RTI application particularly with regard to Apex Bodies/Societies/Councils such as EPCH, CEPC, NCDPD, BCDI, MHSC, IICT etc the concerned section of Hqrs office dealing with the cases of these organizations take the RTI matter very casually and they feel that after passing the said RTI application to these organizations their duties are over.

The aforesaid agencies sometimes furnish the information and sometimes don't furnish the same with some pretext or the other that they are not covered under the RTI Act,2005. Thereafter, the fate of the RTI application stands sealed and nothing communicate to the appellants. As a result of which the appellants are left out with no other option except to file 1st Appeals/2nd Appeals to the First Appellate Authority(FAA)/Central Information Commission (CIC),New Delhi respectively for obtaining the desired information and putting the department into embarrassing situation.

In order to streamlining the RTI matters ,it has been decided and directed that the moment RTI applications and Appeals are received from the appellants pertaining to the aforesaid agencies , the concerned sections of Hqrs office need to seek the information from the above agencies and they shall be liable to compile the same and furnish the requisite information directly to the appellants within the prescribed time period stipulated under the RTI Act,2005 and may also endorse a copy to the RTI Section, O/o the DC (Handicrafts),Hqrs for information and records.

Besides, the Competent Authority henceforth have **declared/designated** the following Officers of the O/o the DC(Handicrafts), Hqrs as the Central Public Information Officers (CPIO's) for their respective organizations mentioned against each and will be responsible to furnish the requisite information directly to the appellants in all respects within the prescribed time period stipulated under the RTI Act,2005:


