Subject: Allocation of funds from Other Revenue Expenditure to organize Craft Demonstration cum Awareness Programmes (CDAPs) at School/College campus under Marketing Support and Services (MSS) component during FY 2025-26-reg.

In exercise of powers delegated to the Development Commissioner (Handicrafts) as Head of Department by Integrated Finance Wing, Ministry of Textiles vide order no. 1/3/2021/DCH/B&A/DFP dated 25.11.2021 and in supersession to order no. G-20013/42/DC(HC)/BGT/2004 dated 05.05.2015 and dated 07.05.2015, I am directed to convey the sanction of president of India for allocation of Rs. 3,01,50,000/- (Rupees Three Crore One Lakh Fifty Thousand Only) to the Regional Offices for organizing 603 (Six Hundred Three) Craft Demonstration cum Awareness Programmes (CDAPs) at School/Collage campus within their jurisdiction for a period of 03 days during FY 2:025-26. Terms and Conditions:

- 1. Every HSC will organize One CDAP every month (except for the month of February, March & June) amounting to total 9 CDAPs during the FY 2025-26.
- During the period of examination month/summer holidays any restriction imposed by State & Central govts., the concern RO/HSC shall prepone/postpone the event only after intimation to the MSS Section of this office in advance and with the prior approval of DC(Handicrafts).
- 3. Each CDAP Shall have minimum 04 MCP artisans and shall be conducted for minimum of 3 days at school/college campus.
- 4. The monthly target achieved will be put up for information to JDC(HC)/ DC(HC).
- 5. The HSC Shall conduct CDAP in uncovered Districts by organizing 01 CDAP per district (where the marketing events have not been organized during FY 2025-26)
- 6. All payments including honorarium for expert/faculty etc. must be made through PFMS/Account Payee cheque/draft/NEFT/ECS/RTGS only.
