## Subject: - Annual Program for implementation of GSHPP training under Other Revenue Expenditure head for the FY 2025-26 - reg.

Sir/Madam,

This is in reference for conducting Guru Shishya Hastshilp Prashikshan Program in the Other Revenue Expenditure Head under Skill Development in Handicrafts Sector (Training) (NHDP) during the financial year 2025-26.

- 2. In this connection, the final calendar for GSHPP activities across India is enclosed. It is requested to kindly mobilize the artisans and make necessary arrangements to implement the programs accordingly. It may kindly be noted that all these programs are to be started as per the calendar (in the month of April and May of 2025).
- 3. Further, HSC will submit the detail report to concern RO for onward submission to HQ for each program. RO will submit the report to HQ asper Annexure-I

## 4. Guidelines, Specifications and Terms & Conditions:

Duration: - 2 Months (25 days per Month, 6 days per week, 6 hours per day) per GSHPP.

A. Selection of Beneficiaries: Selection of beneficiaries shall be conducted in a fair and transparent manner.

Only artisans having valid PAHCHAN card or cards applied for concerned craft category

will be eligible for receiving benefits under this project.

The Assistant Director to ensure that the cards are issued to the artisans who have ii. applied for cards been selected for training before end of the training or else the matter to be escalated to the Regional Offices.

A self-declaration may be obtained from artisans/beneficiaries that they have not iii. availed similar benefit from any other scheme of the Government.

- The HSCs will collect feedback from 10% beneficiaries after the project completion, iv. through email or any other suitable means and convey the same to Regional Offices for onward submission to HQ asper Annexure-II.
- The HSC to identify top five artisans in each programme & share the details with RO V. & HQ. (Name, Mobile No., Aadhaar card, Reason for selection) Annexure III.
- The artisans selected should be 30% less than 29 Yrs category (is Youth Category). vi.

### B. Monitoring and adherence to schedule:

a. All programs shall be monitored by Regional Offices regularly, ensuring timely completion of project and compliance to procedures/guidelines.

- b. Regional Offices are also required to send a monthly progress report in respect of all the HSCs under their jurisdiction as per **Annexure IV.**
- c. Regional Offices to monitor selection of 30% youth in each programme.
- d. Regional Offices to monitor timely submission of bills by HSC for account closure within a month of completion of the programme.
- **C. Documentation and Reporting:** After successful implementation of the programs, the Handicrafts Service Centre will submit (by email) a performance-cum-achievement report to the Regional Offices:-

The salient features of report should be:

- a. HSC-wise complete list of beneficiaries selected for each program.
- b. HSC-wise details of beneficiaries in DBT format and procedure followed for selection of beneficiaries in each program.
- c. Minimum Five Photographs of the training, comparative before & after photographs of trainees' work showcasing improvement in skills of artisans.
- d. Head-wise expenditure, details of suppliers, procedure followed for purchase, PFMS statement for expenditure incurred etc.
- e. Project Implementation Report submitted by HSCs for each program.
- f. Specific remarks on performance of HSCs.

#### D. Terms and Conditions: -

- 1. Funds shall be utilized for the aforesaid programme only.
- 2. The selection of beneficiaries/artisans should made only from concerned category for beneficiaries as per sanctioned program.
- 3. All the beneficiaries/artisans must be genuine PAHCHAN card holders and while selecting the beneficiaries, preference shall be given to artisans who have not participated in any programs in the previous years.
- 4. All the expenditures / payments must be made through Public Financial Management System (PFMS) only, as per the instructions from Ministry of Finance.
- 5. All expenditures shall be incurred as per the provisions of the GFR and Department of the Expenditure guidelines.
- After completion of the event, field offices shall submit Performance-Cum-Achievement Report, clearly indicating the outcome of the event (physically and financially) to concerned Regional Offices.
- 7. The component-wise breakup of the sanctioned amount represents the permissible upper limit of expenditure and the admittance thereof shall be subject to actual.
- The event and fund utilization shall be completed within the financial year 2025-26 and concerned Regional Offices shall ensure the same & also timely quarterly booking of budget.
  - 9. The DDO of HSC/RO of O/o the DC(Handicrafts) of concerned field offices are authorized to draw and disburse the amount in question.
